The redeployment of surplus teaching staff in Private Aided Degree Colleges in the State is under consideration of the Government for quite some time. It has come to the notice of the Director of Collegiate Education, Andhra Pradesh, Hyderabad through various reports including the reports of the internal Audit of this Department, that certain lecturers working in Private Aided Colleges are being paid their salaries from Grant in Aid even though they are not having sufficient workload due to uneconomic student strength in various groups and subjects for the last three academic years. If these lecturers are continued in the same places without properly and fully utilizing their services to cater to the educational needs of the students, it leads to misuse and wastage of public funds and loss to State exchequer. Also there is a need to shift the students to local/ nearby colleges from those colleges wherever uneconomic strength is noticed and as a consequence, the identified surplus staff are also to be shifted to needy colleges for better and fuller utilization of their services. The shifting is proposed to protect the welfare of the staff to avoid the stoppage of Grant in Aid to such posts and to avert retrenchment of staff, who otherwise will have to be terminated on account of uneconomic strength continuously for three or more years. On the other side, due to administrative and other reasons, number of lecturer posts are vacant in Govt./ Private Aided Degree Colleges in the State.

The Govt. prescribed the minimum economic strength to Private Aided Rural/Urban Colleges vide the reference second read above. Based on the audit reports of the Department regarding the students strength and workload position, the teaching staff requirement was reviewed with the Correspondents/ Principals of Private Aided Colleges in the months of August and Sept. 2005 and surplus lecturers were identified.

Subsequently, through the correspondence vide the references third to sixth read above, the Govt. have provided guidelines and accorded permission for the redeployment of the surplus teaching staff of Aided Colleges, exempting from the condition at para-3 (b) of G.O. Rt. No.890 Edn., Education (CE.II) Department, dated 02.08.1996 and to shift the surplus teaching staff to needy colleges having sanctioned posts and requisite workload.

Keeping in view the uneconomic strength in certain courses/sections/groups, as the case may be, and consequent on decrease in the workload in the subject concerned due to decrease in the student enrolment, certain lecturers working in the department/subject of Private Aided Colleges were found surplus. The identified surplus staff of Private Aided Colleges are now redeployed to needy Govt./ Pvt Aided Colleges to work as 'On Duty Basis' temporarily.

In view of the circumstances explained above, the Director of Collegiate Education has decided to redeploy the following surplus lecturer of Private Aided College to needy Govt./ Private Aided College as detailed below:-

**Dr.M.Nirmala Kumari** Reader/Lecturer in **Public Administration, Sri Padmavathi Mahila Kalasala, Saidabad,Hyderabad** whose post is declared as surplus due to decrease in student strength/ lack of workload is temporarily redeployed as **"On Duty Basis"** to **Government Degree College,Vidyanagar,Hyderabad**

The Correspondents of the Aided Colleges concerned are requested to advise the redeployed lecturers on the last instruction day of the academic year 2005-06 or there after, but before 25<sup>th</sup> March 2006 to enable them to join duty immediately at the college to which they are redeployed. The surplus lecturer identified and re-deployed as above, shall be brought back to their parent College, if there is increase in the students strength and workload in the subject and needed in the subsequent years, on receipt of a report from the parent college and after a review by the Department.
- iv. The surplus staff now redeployed will continue to draw their salaries from the grants released to their parent institutions. The Correspondents are requested to draw their salaries from the provision of GLA already sanctioned to their parent institution without any delay based on the *attendance certificate* of the preceding month received from the Principals of Government/ Private Aided Degree Colleges concerned where they are now drafted to work as "On Duty Basis".
- v. The Principal/ Correspondent of Government/Private Aided College is informed to send the Attendance Certificate to the parent institution to which the redeployed lecturer originally belongs, every month for drawl of his/her salary from the provision of Grant-in-Aid.
- vi. The dates of relief and joining duty of the redeployed lecturers shall be reported to the Director of Collegiate Education / Regional Joint Director of Collegiate Education / Principals of the identified Govt. Colleges of the districts promptly.





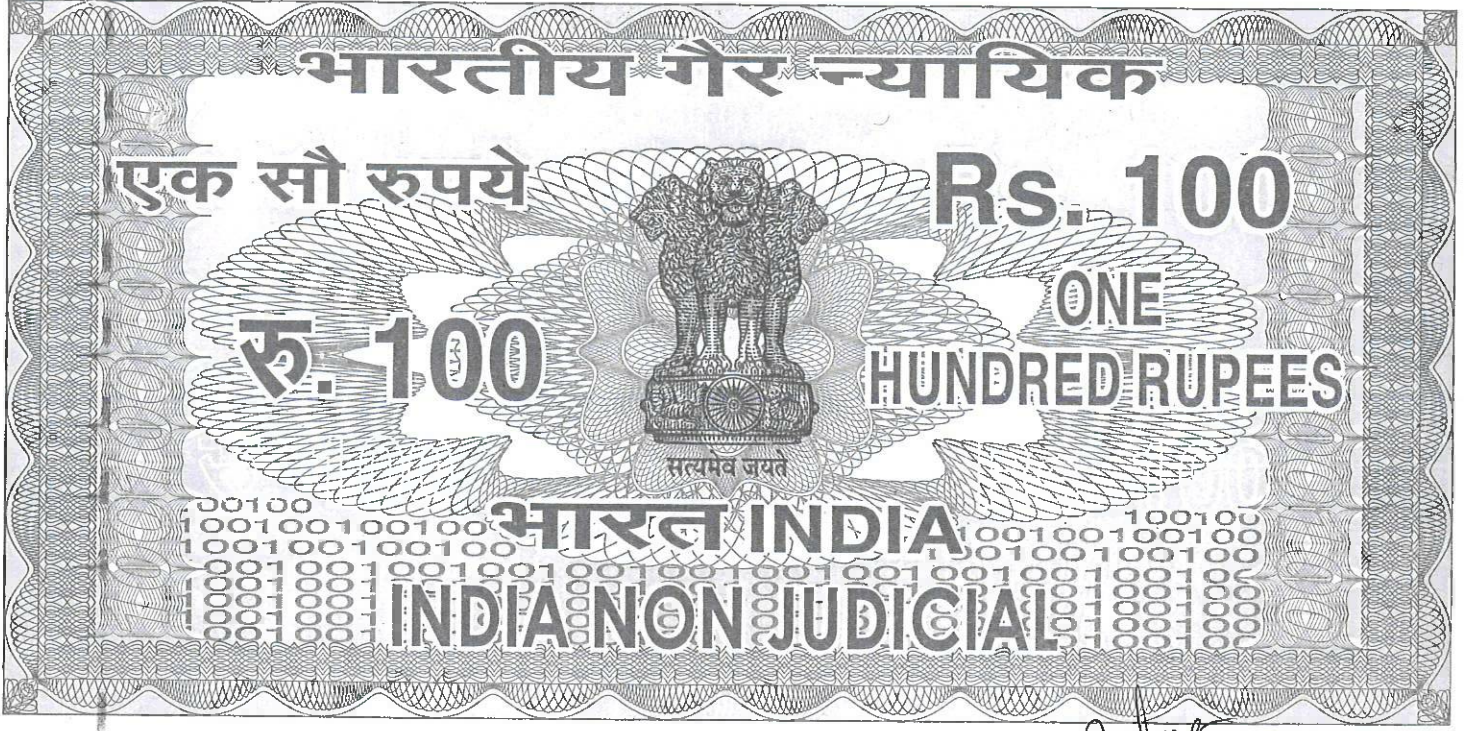
