- 1) All the Principals of Government Degree Colleges in the State shall notify the sanctioned vacancies through press note where there is required workload in the subjects.
- 2) The Guest faculty will be selected by the following **Three Member Committee** i.e.,
 - a) Identified College Principal
 - b) Principal of the College
 - c) subject expert of the College
- 3) The Selection will be made basing of the following conditions
 - i) PG 55% of marks
 - ii) NET, SLET, Ph.D in the concerned subjects will be given preference.
 - iii) The Candidates with teaching experience will be given preference (Service Certificate produced).
- 4) The Guest Faculty will be paid as per G.O. in the reference 5th read above.
- 5) Their services may be utilized till the end of the academic year.
- 6) The candidates should give an undertaking that they will not claim for regularization of their services in future.
- 7) The Guest Faculty engaged may be informed that they are not entitled for any kind of benefits on par with the regular employees since they are purely engaged on payment on hourly basis.
- 8) The Guest faculty will be given the local candidate in the District.
- 9) The Guest faculty engaged may be instructed to maintain teaching diaries and submit work done statements promptly.
- 10) Remuneration will be paid to the Guest faculty after obtaining work done statements from the Guest faculty concerned, duly attestation of HOD concerned.

ORDER:

In the G.O. 1st read above, the Government has enhanced the remuneration from Rs.50/- to Rs.100/- to the Guest Faculty working in Government Degree Colleges in the State, subject to the condition of maximum of 72 hours to each Guest Faculty in a month.

2. In the references 2nd, 4th and 5th read above, the Commissioner of Collegiate Education, Telangana State, Hyderabad, has requested the Government to issue suitable orders for enhancement of Guest Faculty remuneration from Rs.100/- to Rs.300/- per hour, subject to a ceiling of Rs.21,600/- per month, for maximum 72 hours, to the 184 Guest Faculty working in the Conventional Courses against the sanctioned posts.

3. After careful examination of the matter, the Government hereby enhance the remuneration of Guest Faculty from Rs.100/- (Rupees One Hundred) to Rs.300/- (Rupees Three Hundred) per hour, subject to a ceiling of Rs.21,600/- (Rupees Twenty One Thousand and Six Hundred only) per month, for a maximum of 72 hours, to the 184 Guest Faculty working in the Government Degree Colleges in the State, in the Conventional Courses, against the sanctioned posts.

4. The Commissioner of Collegiate Education, Telangana State, Hyderabad, shall take necessary action accordingly.

5. This Order issues with the concurrence of the Finance (HRM-I) Department vide their U.O.No.13148-C/282/A2/HRM.I/2017, dt.15-11-2017.

If their performance is poor in the ensuing assignment and examinations also, the Principal reserves the right to terminate their services immediately.
- 13) If the Guest Lecturer is found to come indisciplined conduct in discharging his duties, he may be terminated.
