Tharuni runs Resource Centers in Villages for Adolescent Girls in collaboration with an IT company – Hexagon under its CSR initiative. In these centres' girls are being trained in Soft Skills like Spoken English, Basics of Computers, Life Skills and Health Education.

Tharuni Founders and Volunteers have been Resource Persons on various issues related to women and girls to sensitize the students and faculty of Government Degree Colleges. We would like to continue our association with Government Degree Colleges, to give inputs for the capacity building of the students in Vivekananda Government Degree College, Vidyanagar, Hyderabad collaborating with its ICC and WEC. Students can also get a free copy of our News Letters, books and materials and utilize SMS Helpine – Tharunopayam to solve their problems.

**Report:** Department of English in Collaboration with ICC/WEC/TSKC organized and extension activity on 7<sup>th</sup> February 2019, at seminar hall VGDC. Ms. Anita Abraham Head Department of English, WEC/ICC Coordinator introduced the chief guest Dr. Mamatha Raguveer founder of (NGO THARUNI). Ms. Bangla Bharathi Senior Faculty briefed the students on the objectives and aims of the extension activity.

Dr. Mamatha Raguveer in her talk on **Women Empowerment in the Indian Context: Issues and Challenges**, said that empowerment of women means equipping women to be economically independent, self-reliant and having positive self-esteem to face difficulties in life.


Dr. Raguveer, related stories of gruesome domestic violence cases, acid attacks and rape victims and how their NGO had to tackle with the obstacles they faced while solving the women related issues. She emphasized that steady rise in the adversities faced by women and a girl is due to lack of education, health and safety. She also stressed on the need to improve initiatives and legislation that empower women and girls.

In this context TSKC Coordinator, Dr. Suchitra Singh, (TSKCCell) in collaboration with Department of English and WEC proposed to start a certificate course on Communication Skills and Personality Development exclusively for Girls.

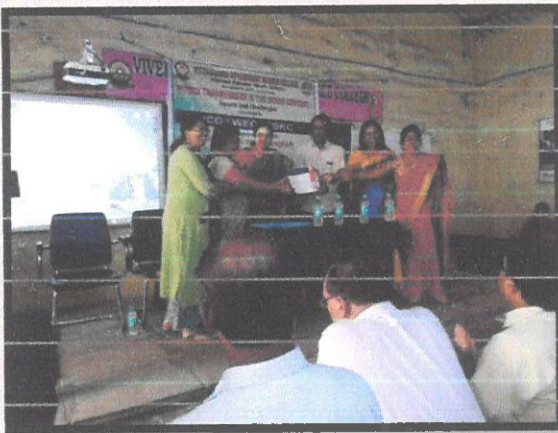
The session ended on a positive note as the girls enrolled for Certificate Course and vowed to empower themselves.

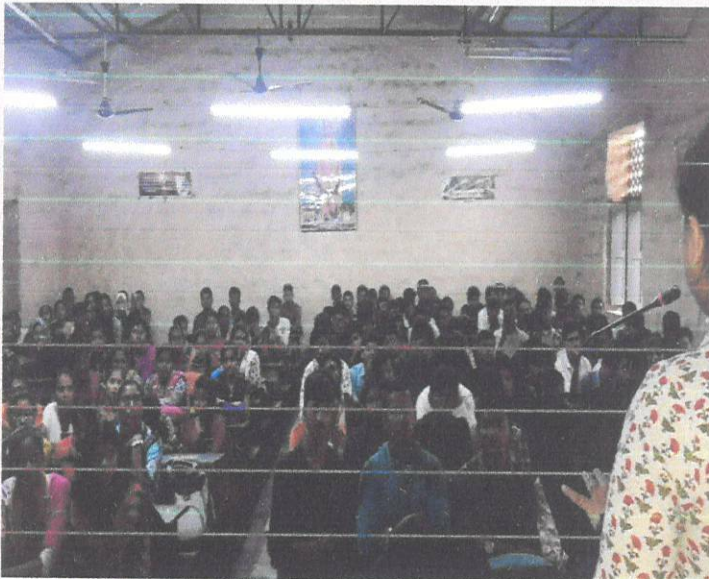
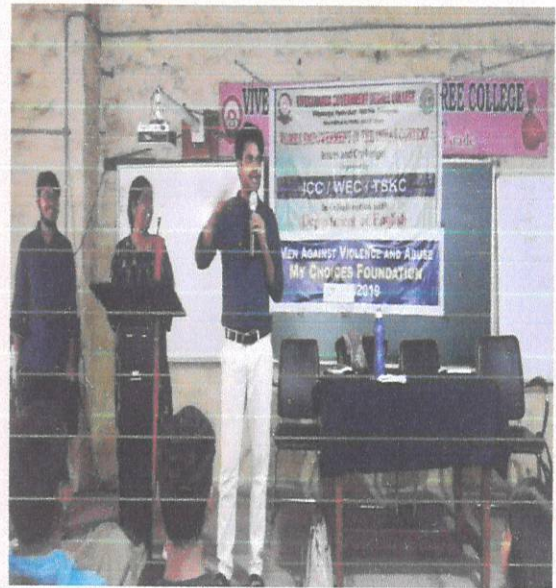

The monetary expenses for each project would also be determined mutually at the start of every programme.

## ROLE OF RUBAROO:

For the purpose of this partnership, Ms Monisha Vemavarapu, CEO, Rubaroo, will be the point of contact.

- **Facilitation:** Rubaroo (or its partnering network) will facilitate and design all the sessions for any programmes, including any orientations, mentoring, feedback, mobilisation addas, or debriefs that may happen. The broad design, timeline, and the essential details of each programme intervention would be shared with the point of contact at Vivekananda Government Degree College.
- **Dates and Venue:** The dates for all the programmes would be decided and mutually agreed upon by Vivekananda Government Degree College and Rubaroo prior to any programme, keeping in mind the academic calendar and schedule of the institution.
- **Review and Reporting:** Continuous feedback and assessments will be held over the duration of the partnership period to review the relationship health status.
- **Programme Coordinator:** Due to the varying nature of programmes, a programme specific coordinator would be identified and appointed, and communicated with the institution for smooth functioning of the programmes.

## ROLE OF THE INSTITUTION:

- **Mobilisation and Participation:** Vivekananda Government Degree College would be responsible for identifying specific departments for participation in different programmes, and ensure diversity of participation inclusive of caste, class, religion, gender, physical ability, language, and other parameters as defined at the start of each programme.
- **Attendance:** Vivekananda Government Degree College would also ensure continuous participation of the students by encouraging them, and also making a note of the attendance of participants for each programme to discourage dropouts in the middle of any programme.
- **Programme Coordinator:** Ms Bangla Bharathi from the institution would work in close association with the Rubaroo Coordinator. The coordinator will support processes, mobilisation, attendance and participation, coordination with the students and support in review and feedback processes.
- Coordinating with parents and guardians (wherever needed), getting consent and indemnity forms from them.
- Coordinating, supporting logistics, and communicating essential information with the students of each programme.
- Communication of important decisions between Rubaroo and the institution.

## CONTRIBUTION:

Most of the programmes offered by Rubaroo, that are funded by partner organisations would incur no expenses by the participants and it would be borne by Rubaroo. If any costs are identified for any programme offered, this would be shared and agreed upon, over email, with the institution, and mutually agreed upon by both parties. Additionally, the following points may be highlighted.

1. Insurance for the students for each programme (wherever needed) would be borne by the institution.
2. Medical and first aid kits would be provided by the institution if the venue is Vivekananda Government Degree College itself. For venues outside the institution, Rubaroo would provide medical and first aid kits.
3. Expenses incurred on stationery and other resources would be discussed at the start of every programme, and mutually agreed upon.
4. Local travel or any conveyance charges would be shared with the institution as per each programme budget. As per default, we can assume that no travel would be reimbursed to and from the venue of any workshop, for the students.



## Activities Through MoU with Ruberoo

### Ruberoo- Agaaz-e-baatcheet October 2018

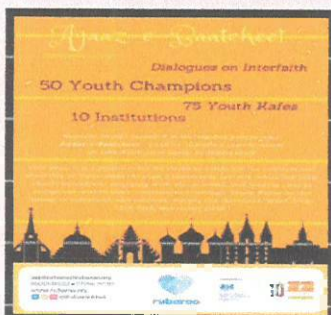
**Ruberoo** has invited VGDC, Vidyanagar to partner for '*Agaaz-e-Baatcheet*', a leadership programme with 50 Youth Champions in Hyderabad. . These Youth Champions, representing diverse partner institutions and backgrounds, will go through a leadership journey where they will learn about themselves and engage with social issues, to lead change initiatives within their communities.

**Objectives:** to develop leadership qualities, be a team player  
To develop communication skills, develop tolerance through dialogue.

**Being a community Partner**, the faculty gave an orientation to all the first, second and final year students. Students who have shown interest were nominated from the college and they had to register online by filling up a form, and based on their application, out of 20 students, 12 were selected and were divided into two batches. Batch one had a 3-day Orientation at Madina College, Himayatnagar and Batch 2 at MANUU, Gachibowli. They participated in the 3 day programme to become Youth Champions.

**Outcomes:**

Students implemented social action Projects (SAP) and have overcome their stage fear, gave a feedback that they improved their communication skills.

**Youth Civil Activism Network (YouthCAN) Innovation Lab 3-day (1st-3rd November)**  
**residential workshop@ Hotel Mariotte, Hyderabad**

**Objective:** To develop creative thinking, identify fake news on social media and spread awareness among the youth.

Work shop aimed on crafting new solutions to disinformation and dubious content on social media. Out of 15 students from 2<sup>nd</sup> and 3<sup>rd</sup> year who applied online, only 3 were selected based on their application.

Aravind from MSCs final year,  
Shaik Imran and Hrithik Singh from B. Com second year were selected and attended the 3-day residential program with 32 young activists of other colleges from Hyderabad. They got to work with industry experts to flex their creativity and craft innovative new campaigns that take on the growing problem of disinformation and “fake news” in India and address the consequences that it has in undermining democracy and fueling polarisation and violence.

**Outcome:** Students identified the fake news from various forwards they got on WhatsApp, Facebook, Instagram and immediately alerted the group.

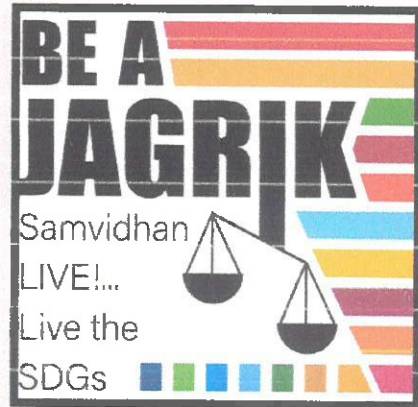

### **Be a Jagrik - Samvidhan LIVE! Live The SDGs**

(The College has entered into an MoU with Rubaroo and JagrikSamvidhan live is an Inter Departmental activity in collaboration- with Department of History and Department of Political Science/Public Administration)



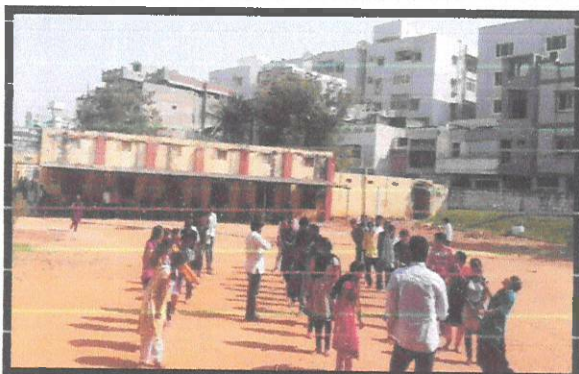
Led by Rubaroo in Hyderabad, Samvidhan LIVE! The Jagrik Project is a campaign aimed at building young people's capacities in learning about the Indian constitution experientially. A 2-month campaign with more than 60 young people in Hyderabad, the participants led tasks based on the Fundamental Rights and Duties. The campaign is led by ComMutiny - The Youth Collective, Delhi and regionally more than 26 organizations across India are a part of this public initiative.


#### **Rubaroo'sSamvidhanLive!**

This campaign aims to engage 50 young Jagriks (Jagruk + Nagrik or awarecitizens) in Hyderabad between the age of 18 to 25 years from diverse socio-economic backgrounds to understand and gain hands on experience of the Indian constitution and the UN Sustainable Development Goals. The campaign has been designed in the format of a real-life simulation activity which creates a platform for young people to live the ground realities of the Constitution, to understand the fundamental rights and duties and to understand the need for SDGs.

After filling a nomination form, 50 youth were selected to participate in the Be a Jagrik Journey. Over the course of the Be a Jagrik Journey, the Jagriks participated in the following activities:

1) 2-day Orientation workshop - Be a Jagrik Orientation Workshop was held on 22nd and 23rd of November at our college. Each day one batch of 30 students attended the workshops. They were provided a working lunch and snacks.
